

Title: Category Technical Scrutineer & Driving Standards Officer, 944 Challenge

Reports to: Technical sub-committee, 944 Racing Association

Track Hours: One hour prior to first qualifying or race until all matters resolved after last race.

Remuneration: Set fee for race weekends negotiated with 944 Racing Association plus reasonable expenses. End of year inspections will be paid by the 944 Racing Association. Work for individual competitors will be at their own expense.

Scrutineer

Description: Provide technical advice and perform inspections on vehicles competing in the 944 Challenge series. Communicate with the Technical sub- committee and track officials in regard to any clarification or breaches to the rules and penalties applied.

Duties:

- Maintain a good working knowledge of all relevant rules including
 - 944 Challenge Sporting Regulations
 - o 944 Challenge Technical Regulation Rules Clarification Document
 - o 944 Challenge Driving Standards Document
 - o CAMS General Requirements of Automobiles
- Prepare an audit schedule for the year. The technical content of the schedule is to be agreed with the Technical sub-committee. The timing of audits is at your discretion and should not be discussed with any competitor including Committee members. Where concerns have been raised, the Committee may request that a specific area be targeted at a given round.
- Perform technical audit inspections at the track as per audit schedule.
- Where rule breaches have been found, the Technical Scrutineer will report to the Technical sub-committee on any findings of cars that may be non-compliant with the Technical Regulations. The Technical sub-committee will then further inspect that vehicle and at their absolute discretion may require selected cars to be impounded and removed to an appropriate place as determined by them for detailed examination.
- Ensure all competing vehicles have seals fitted to engines and gear boxes. The location of seals is to be agreed with the Technical sub-committee.
- Maintain a register of engine and gearbox seal numbers and check regularly to determine if major components have been changed.
- Perform a complete audit of the top 3 finishing vehicles for the season along with any other vehicle nominated by the Committee. Audit will be as per a checklist agreed with the Technical sub-committee.
- Offer technical advice on rule compliance to competitors as required. Refer any unclear rules to the Technical sub-committee.
- Advise the Committee two weeks in advance when unable to attend a round or all races at a round so that alternative arrangements can be made.
- Provide a written report to the Technical sub-committee on audits and results along with any protests after each round.

Driving Standards Officer

Description: Provide advice and perform evaluations on racing incidents in the 944 Challenge series. Communicate with the Committee and track officials in regard to any clarification or breaches to the rules/standards and penalties applied.

Duties:

- Maintain a good working knowledge of all relevant rules including
 - o 944 Challenge Competition Rules
 - o CAMS National Competition Rules
- Investigate racing incidents and liaise with competitors regarding the cause, where possible by utilising competitor video and data.
- Ensure that incident reports are completed by all competitors involved in car-to-car contact.
- Where possible obtain a copy of video/s for later review by the Committee.
- Attend meetings and hearings with track officials regarding incidents when required.
- Offer advice to competitors as required.
- Advise the committee two weeks in advance when unable to attend a round or all races at a round so that alternative arrangements can be made.
- Provide a written report to the Committee on any incidents or protests after each round including a summary of damage caused.
